NOTE: Any permit may be pulled at any time at the discretion of the Road Foreman and/or the Middlesex Board of Selectpersons. The holder of the permit will be held financially responsible for damages incurred due to tracking mud onto the road or from turning the road into mud or any damages incurred during the applied for hauling operation.

Travel is restricted when roads are posted, and Town Bridge #34 is limited to gross vehicle weight of 40,000 lbs.

Travel is restricted when roads are posted, Three Mile Bridge is limited to gross vehicle weight of 16,000 lbs.

This approval shall be effective for no more than a one-year period ending March 31, 2022. If this is a fleet permit, this approval covers all vehicles bearing the company name. If the permit is to cover unmarked company trucks, please attach a list to this form giving the year, make, VIN number, maximum weight and registration number.

The holder of a permit shall be liable for any damage to highways or bridges per VSA Title 23, Sec. 1400a and is required to furnish the Town of Middlesex a valid Certificate of Insurance, **indicating the Town of Middlesex as the Certificate Holder**, in the following amounts: a minimum of \$100,000/\$300,00 Personal Injury Liability Coverage and \$100,000 Property Damage Coverage.

1. Permit is valid for up to one year, expiring on March 31.
2. Please include an administrative fee of \$5.00 for each single permit, or \$10.00 for a fleet permit.
3. Single vehicle permits must be carried in the permitted truck. Fleet permits are not required to be carried in the trucks.
